In South Africa, as with most other countries in the world, we have copyright laws that protect all music.

The purpose of these laws is to ensure that “royalties” get paid to the people, who wrote, created and produced the music we listen too.

There are basically three types of “Music Rights”.

They are:

- Performance Rights [It belongs to people who own the music]
- Mechanical Rights [It is the royalty payments that music publishers earn]
- Needletime Rights [This is what the recording artists get paid when their music is played in public]



Everyone who buys music pays royalty fees because the fees are already included in the album price. When you look at a music album cover, on the back of the album, you will see a copyright notice.

The notice is crystal clear. It says something like. *This music is for personal entertainment only. Copying, hiring, lending, public performance and broadcasting are prohibited.*

In terms of the law, you cannot do these things:

- You cannot play music in public places without prior permission.
- You cannot *rip* the music to use in, for example, on your Facebook page or for a YouTube video, or for any other digital stuff you want to do.
- You can't copy it or rent it out or even lend it to someone.



At this point, I know many people do not worry about this. Many may even say something like: *“Bah...I don't care, I paid for it - I will use it as I like”*.


And you know what. They are right, it is a free country. They can do what they want and as grown men and woman, they can also take responsibility for their own actions. It has nothing to do with me...

But when you are a public or corporate business, it is not so easy to ignore these laws.

For example:

- When a radio station or broadcaster plays songs from music artists, they need permission to use the music, and they need to pay the necessary royalty fees.
- Advertising agencies that use background music in their radio or TV ads need to pay the Music Right fees before they can make the ads.

- Online Games & App developers who use music in their software need to pay the necessary Music Right fees.

- **SAMRO.org.za** – They make sure that everyone who uses or plays music in public places buys a license before they are allowed to do so. Their motto is: “playback time” is “payback time”.
- **CAPASSO.co.za** – They focus on Mechanical Rights on music in South Africa.

Something Else: You may not know this yet, but these organizations recently started an aggressive program to get EVERY company and organization who use production and background music in their businesses to come on board and pay Music Rights. Even the prisons in SA now pay these fees.




